Dear HARMON LYNN WILFRED :

On 07/26/2005 a review of your child support or foster care fee case was completed. The review was based upon current child support guidelines. A copy of the proposed guideline calculation is attached.

The review results indicate:

- There will be no change to the amount of child support or foster care fees due.
- Your current child support or foster care fee amount should be changed. The proposed amount is \$50.00.
- The medical support coverage may be included or changed in the order.

If a change is indicated and if you agree with the above change, please sign the enclosed Stipulation before a notary public and return it to me within ten (10) days at the office address listed above.

If you disagree with the above results, you have the right to challenge the findings. If you wish to challenge, you must make your request, in writing, within thirty (30) calendar days from the date of this letter. The challenge must be sent to the child support enforcement office listed above. Your

challenge must include proof that inaccurate information was used or a mathematical error was made. If no change is indicated above and a written challenge is not received in this office within thirty (30) calendar days, this office considers the review finished. If a change is indicated and the signed stipulation is not received in this office within thirty (30) calendar days, this office will initiate court action.

This proposed amount is not final until an order is entered by the Court. The currently ordered amount must be paid until the order is entered. The CSE Unit will send an income assignment to the employer after the order is entered by the Court.

Any party may request, in writing, a review of the child support or foster care fee order if the party believes that there is a substantial and continuing change which would cause an adjustment of the court order.

Dear Mr. Wilfred,

We have completed a review of your current child support order and determined that a modification of the support order is needed. The enclosed documents show the information that was used in the review.

It is your right to request a hearing for modification of your order. However, our office prefers to work with you to reach an agreement without going to court. Therefore, we have enclosed a stipulation for you to sign and send back to our office if you agree with the modification.

If you are in agreement with the enclosed stipulation for a modification, please sign the stipulation and return it in the enclosed business reply envelope. The stipulation must be signed in front of a notary public. Your original signature will be combined with the original stipulation we have on file, which is the same as the document we have sent you. Please return the stipulation to our office within **14 days of the date of this letter.**

If you disagree with the review results, you have the right to challenge the findings. If you wish to challenge, you must make your request in writing to our office within thirty calendar days (30) from the date of this letter. Your challenge must include proof that inaccurate information was used or a mathematical error was made.

If our office is unable to obtain an agreement to the new child support amount within 30 days of this letter, we will request a court hearing.

The parties have reached an agreement for modification of child support and related issues, and the Obligor has specifically consented to the entry of this Stipulation as an Order of the Court.

1. The Obligor is the natural father of the child(ren) named herein.

There has been a continuing, permanent change in the circumstances of the parties and the child(ren) sufficient to justify the modification of the monthly child support obligation owed by the Obligor.

2. The monthly child support obligation of the Obligor shall be modified to the sum of **\$50.00** per month as current child support, effective **September 1, 2005** and to continue on the **1st** day of each month thereafter until said child reaches the age of 19 years, becomes emancipated, or until further order of the Court.

5. Any party may request modification of this child support order if such party believes that there is a substantial and continuing change in circumstances, which would cause an adjustment of the court order.
6. Pursuant to C.R.S. 14-10-117, 26-13-114 (1996 Cum.. Supp.), all payments shall be made payable to the Family Support Registry, PO Box 2171, Denver, CO 80201-2171. Your payment must include your name and FSR number to identify your payment. **Your FSR number is 02098614.** No credit will be given for payments made in any other manner.
7. Pursuant to C.R.S.14-14-111.5 (2) (f) (as added July 1, 1996), the amount of child support, maintenance, child support when combined with maintenance, child support arrears, or child support debt shall be deducted and withheld from the income of the Obligor.

8. The Obligor and the Obligee are ordered to notify, in writing, the El Paso County Child Support Enforcement Unit of any change of address or employment within ten days of such change.

9. The provision for providing medical or medical and dental insurance for the minor child(ren) is as previously ordered.

Pursuant to C.R.S. 14-10-115 (13.5)(a), the Obligor is ordered to provide medical or medical and dental insurance for the minor child(ren) so long as said insurance is available or when said insurance becomes available through a currently effective insurance policy available through an employer or through a private carrier. The party providing the insurance shall cooperate in providing insurance claim forms, identification cards, and other necessary documentation to the other party.

10. This agreement does not preclude other remedies available to the Office of the El Paso County Child Support Enforcement Unit, including but not limited to seizure of tax refunds, garnishment or income assignment, to satisfy any arrearage.

11. All prior orders of the Court which are not specifically modified by the terms and conditions of this Stipulation and Order, and which are not in conflict with such terms and conditions, shall remain in full force and effect.
