Re: Second Open Letter to now President Donald J. Trump

Update and Application for US Ambassadorship to New Zealand

Dear President Trump,

As you know, my first open letter to you provided a basic history of my faithful service to America both in the military and as an honourably discharged veteran of the Vietnam era; and thereafter an "asset' for the CIA under the Clinton Administration from 1997-2000. I continue to hold the evidence of the gross criminal misconduct of Bill and Hillary Clinton and await your instructions through your now Attorney General Mr Jeff Sessions.

The challenge with my story and evidence is in proving the veracity without an official investigation.
