SUBJECT: Harmon Lynn Wilfred

The writer has been approached by Mr. Harmon Wilfred for assistance in respect of several matters concerning his "status" and in respect of historic matters of relevance in the United States of America.

The writer has been fully briefed and has had access to all papers and actions in the public arena. The writer, in view of Mr. Wilfred's present circumstances, has agreed to act on a purely voluntary (pro bono) basis.

The writer, on behalf of Mr. Wilfred, has endeavoured to obtain the assistance of lawyers in Colorado and has been more than a little surprised that not one he approached would accept instructions to investigate the actions of State Officials and the legal status of proceedings against our client.

The writer has a long relationship with the USA including over 20 years of close involvement with the City of Seattle, and is the holder of a Proclamation from that City. In all those 20 years the writer has never met such 'stonewalling'; and indeed what would appear to be fear on the part of officials.

The letter from your office simply reinforces the writer's concerns insofar as Mr. Wilfred is concerned. All Mr. Wilfred has sought to do is to request a search and details of the FBI's Criminal Justice Information Services Division's Criminal files for any records pertaining to him. In the writer's view that information should be available to any individual making a proper request to your Office irrespective of whether or not that person is an "alleged fugitive from justice". We note with fascination that there is an active Warrant for Mr. Wilfred's arrest and that such Warrant was issued on the 1st April, 2011 by the El Paso County Sheriff's Office for "Failure to Appear".

You will be well aware that Mr. Wilfred has been out of that jurisdiction (and the USA) for over 11 years. He is now in New Zealand.

It is beyond our comprehension that a Warrant could be issued, according to your letter, so many years after Mr. Wilfred had left the jurisdiction and when this fact was well known to all officials in the Sheriff's office and to your Department. Something is not right !

We cannot conceive of any possible legal basis for the application for and issue of such a Warrant unless there has been gross misfeasance in public office committed by those involved. A report has been obtained from a para legal that made enquiries for Mr. Wilfred and we attach that report for your reference. If it is inaccurate in any way then please advise accordingly with specifics. If indeed it is accurate then your Department should be investigating the Officials in El Paso and the State , not Mr. Wilfred.

The fact that the Warrant has been sought and issued in such circumstances and so very many years after any possible cause of action came into existence (and our client strenuously denies that any such cause of action exists or existed) would indicate an abuse of process and possibly more serious and illegal actions at least on the part of officials in the State of Colorado.

In our opinion there is a compelling case for these actions to be investigated rigorously by the FBI rather than the FBI simply and without proper enquiry rejecting Mr. Wilfred's proper request. At this stage we have been instructed to repeat our client's request for copies of his records including all documents provided to your office by the Office of the Sheriff of El Paso County and including the affidavit(s) or other papers/ files used in order to obtain the issue of the Warrant to which you have made reference.

If the situation with regard to any proceedings against Mr. Wilfred, whether valid or based upon a subversion of your legal system, is as you have stated, then we see no justification for the continued endeavours to avoid the production of the information sought.

We do not see that reference in these circumstances to "Doyles Case" is anything other than a 'smokescreen'. We can but assume that, unless established otherwise to our satisfaction, there are in fact matters that would not withstand any impartial judicial scrutiny.

We can see no reason for your Department's reluctance to provide the information sought and would ask that the decision be reconsidered and reversed.....

We look forward to your reply and receipt of the information sought by Mr. Wilfred.
