**These are the Closing Arguments presented to the Court of Public Opinion summarizing the conspiracy between Canada, New Zealand and the United States against our family and the global human family, under the common thread of the Clinton/CIA/Rothschild cartel, that we have now coined the “*Global Shadow Government*” (“GSG”).**

**Could this be what gives Hillary Clinton her renewed energy as leader of the “resistance” in her global tour to thumb her nose at President Trump while reinstating the Clinton Foundation crime syndicate?**

**In previous episodes, a detailed evidentiary case has been presented to show the influence of the GSG now having control of the Five Eyes (CIA) and the global nation-state central bank network (Rothschild’s) otherwise known as the global economy.**

**Understanding that the leaders of these nations are the ultimate players of this now embryonic but advancing global take-over, unwittingly or otherwise, I hereby challenge them to stand down and confess to their part in this global financial take-over conspiracy.**

**The following provides my closing arguments and summary of this cumulative documentary and YouTube interview case, built through Crowdsource The Truth, upon the body of evidence in my evidential website, [www.luminadiem.com](http://www.luminadiem.com) against the US, Canada and New Zealand to expose the real GSG crime boss (the Clintons) of this international power play. In effect these three nations have become the puppets of the GSG in this global game of bully-boy co-dependent chess.**

## **Wilfred v Canada PM Justin Trudeau, Clintons' "CRA Assassin"**

**The evidence would show that Canada colluded with the US to avoid being exposed** in both my request for investigation against the US, Canada and the Clintons being denied at the US Justice Department in 1999 (by Michael Horowitz under the Clinton administration) and my accepted [UN Human Rights Case #1638-2007](#) in 2007 where 12 articles are documented as violated. The Canadian government also colluded with the US to force us out of Canada in 2001 in fear of our lives, and then charged Carolyn with a multi-million dollar "departure" tax that justified the ultimate freezing of her assets in 2009 to prevent the continued financing of my UN Human Rights case. This is better known as "CRA assassination" or perhaps even terrorism.

**Carolyn's attempt to remedy her tax situation by selling her family holding company shares** to re-establish her standard of living and continue funding my human rights case against Canada has been consistently thwarted by what she is convinced is government support of the Dare brothers in her minority shareholder oppression court action against them as the majority shareholders. Her brothers refuse to allow her shares to be sold or to purchase them in a now 4-year appeal court battle.

**The courts have found in favour of her brothers in spite of them having been reported to the CRA** as committing tax fraud since 2000, by refusing to report their offshore tax holdings and profit in the Cayman Islands. Her late "influential" father cut a deal with the CRA to prevent criminal charges and the file was sealed, disallowing this evidence to be presented to the court.

**The following is a summary of the Canadian Government's coordinated attack** on Carolyn provided by John Hansen, a Crowdsourcer, the Truth supporter and freelance investigative reporter:

***Canadians who value fairness will be appalled** to learn that the Canada Revenue Agency (CRA), possibly to punish her CIA whistleblower husband Harmon Wilfred, brought a very unusual tax judgment against now 66 year old Dare Foods heiress Carolyn Dare Wilfred. The CRA has been charging Carolyn interest in excess of \$1,000 per day on the now principal amount of \$9,000,000 since 2015 after the CRA RETROACTIVELY changed the law on her tax plan originally presented in 2001 by the national tax accounting and law firms of BDO Dunwoody and Frasier Milner.*

***So why doesn't Carolyn just comply with the bizarre judgment, pay the tax and move on** since she owns 27% of Dare Foods, a family-owned company worth hundreds of millions? Carolyn contends that her brothers Bryan Dare and Graham Dare have oppressed her as a minority shareholder by deliberately obstructing her share sale efforts! Only by court action has Carolyn received ANY money from her shares lately, and even that has provided only marginal help because the CRA froze her assets in 2009. Carolyn suspects that the CRA took that step to prevent her from funding Harmon's UN Human Rights cases against what some assert was Canadian government overreach.*

*Carolyn's now four-year court appeal effort has yet to result in a remedy for this gross injustice, and her brothers remain intransigent. While they live in splendor, Carolyn lives like the impoverished heiress in Charles Dickens' brilliant, satirical novel, "Bleak House" which relates the fictional case of "Jarndyce vs Jarndyce" which dragged through the British judicial system for decades without any relief for the impoverished petitioners, although it enriched lawyers until the inheritance was exhausted. Dickens' novel actually led to sweeping reforms in British inheritance law which eliminated much real-life inequity.*

*A public examination of Carolyn's predicament would no doubt result in equally major reforms to Canada's family inheritance shareholder laws. Since years of litigation have not righted a perceived adjudicated wrong or addressed her legitimate quest for relief from this nightmare on Bay Street, Carolyn is now taking her case to the court of public opinion. She and others like her would be profoundly grateful for a transformative outcome like the one put into motion by Charles Dickens' "Bleak House!"*

**Wilfred v New Zealand PM, Jacinda Ardern, Clintons' "Jailer"**

**From the time we arrived in New Zealand in 2001 to escape retribution from the CIA/Clintons,** both Carolyn and I were experiencing what today is known as extreme PTSD. However, for us the stress is ongoing with the real belief that our lives continue to be in danger by the global reach of the CIA. Every ring of our door bell or knock at the door continues to make our hearts skip.

**We made a valiant attempt to create a new life in New Zealand** by obtaining a portion of Carolyn estate from her father and investing in a new technology company as well as creating a family foundation to contribute back to the community. Unfortunately, this was not to be.

**In 2004, when I applied for a new US passport at the US consulate in Auckland,** I was notified that my passport had been confiscated and I must return to Washington to answer to "outstanding issues". As I knew exactly what this meant, for my personal freedom and safety, I was left with no other choice but to renounce my US citizenship and throw myself on the mercy of the New Zealand Removal Review Board for residency. My request and appeal were denied. I then applied for political asylum for which I was fully qualified, including having received credible death threats from the CIA, but again both my application and appeal were denied.

**Although as a stateless person, protected under the UN Stateless Convention and the UNHCR,** New Zealand refused to grant me any status and insisted that I leave New Zealand, full well knowing that as stateless, I could not legally leave or be deported. This began my “jail sentence” in New Zealand with no right to work or travel. Albeit, this was tolerable as long as I resided with my wife Carolyn and could remain useful in managing her New Zealand investments for no compensation.

**Being constantly harassed by the New Zealand media as an “overstayer”,** our family charitable trust and related businesses began to decline; with the last straw being the Christchurch earthquakes in 2010 and 2011. With our charitable businesses in shambles, we sold our successful technology company and our home to remain afloat and continued our effort to obtain legal status for me, all the while suffering financially.

**In 2015, while Carolyn’s residency application was under consideration, she travelled to Canada** to visit her daughter and sell her Canadian family business shares to renew our investment commitment to New Zealand. The day she left, Immigration New Zealand deliberately suspended her right to return without notice as well as further refusing even visitor applications on Humanitarian grounds. It has now been two years and nine months since we were forcibly separated and the pain of that increases daily.

**Although it is clear that I cannot leave or be deported,** and the attempt to force me to leave and enter into another country unlawfully is simply part of a plan to place my life at the mercy of the CIA, the New Zealand Government continues these unmerciful acts of human rights violations under their international treaty obligations.
